TERMS AND CONDITIONS

WPROA divisional circuit co-approval roping fees are non-refundable and non-transferrable. If event is not approved the approval fee will be refunded to the producer.

You must complete a WPROA form and submit it to the WPROA Office in order to produce a WPROA Divisional Circuit Co-Approval Roping event. Non-member entries can be accepted at WPROA Divisional Circuit Co-Approval Roping events.

All dates for WPROA Divisional Circuit Co-Approval Roping events must be approved by the Roping Director. A WPROA Divisional Circuit Co-Approval Roping form and payment **must be received in the WPROA Office at least sixteen (16) days prior to the event.**

All changes to the event must be submitted to the WPROA Office at least 14 days prior to the event.

Producer is responsible for submitting results and payoff to the WPROA office within three business days of completion of the event. If results are not received on time you may be forfeiting your future approval status.

If a producer is putting on a WPROA sidepot (for WPROA Members only) the minimum added money is \$100 with a minimum entry fee of \$25.00. 5% of the total purse is payable to the WPROA.
