

2010 Stallion Enrollment Open September 15, 2009
Enrollment Forms Must Be Guaranteed With A Credit Card & Submitted on or
Before December 31, 2009

\$1000 Enrollment Fee Must be Paid In Full By March 15, 2010
(Payment Option: \$500 on Feb.15, 2010 / \$500 on March 15, 2010)

Money Distribution

- 1) 80% of all monies received from stallion and progeny enrollments will be put into a secure account to be distributed as bonus money.
- 2) Office charge of 20% from all fees paid per horse will be deducted in the year of the payment for promotion and administration of the P.E.S.I. program.
- 3) The bonus money portion of nomination/ enrollment fees from horse not yet of competition age will be held for payout until a futurity horse's four-year-old year unless P.E.S.I. is notified in writing that the horse will not be competing until it turns five years old.
- 4) The bonus money portion of the enrollment fees for horses five years old and older will be added to the total purse the next competition year after payment.
- 5) Bonus monies will be paid on at selected sanctioned events over the course of the season and distributed directly from the W.P.R.A. Office.

General Rules!

- 1) P.E.S.I. reserves the right to refuse any nomination.
- 2) All disputes arising out of the application or interpretation of any rules or conditions of the P.E.S.I. shall be decided by P.E.S.I.
- 3) P.E.S.I. reserves the right to alter the conditions of all or part of the program as it, in its sole discretion, deems advisable. P.E.S.I. may cancel the program at any time and refund money, excluding interest, if it deems the participation is insufficient to justify the program.
- 4) All money will be handled by the W.P.R.A.'s accounting firm.
- 5) There shall be an accounting statement made available to all P.E.S.I. stallion and progeny owners
- 6) A current listing of nominated sires & progeny that are named & paid in full will be on the W.P.R.A.'s web site: www.wpra.com and in Women's Pro Rodeo News.
- 7) To be eligible for bonus money, a horse's owner/agent is responsible for designating on entry forms that the horse is enrolled in P.E.S.I.
