- Horses and riders to be named at event check-in
- Slot horse check-in will be Saturday, October 22nd from 3:00pm to 4:00pm at designated location

# WPRA WORLD FINALS MEMBER OPEN SLOT RACE - GROUND RULES

## Saturday, October 22, 2016 • Night Performance

1. Entries taken on location will be subject to a 10% late fee.
2. Slot race is open to WPRA Members only and all horses of any age.
3. WPRA Member Open Slot race Entry Fee is \$2,500. First payment \$1,500 due by September 2, 2016 and second payment \$1,000 due by October 3, 2016.
4. All partial payments on defaulted slots will be included in slot purse. By making a payment toward the purchase of a slot for the WPRA Member Only Slot race, buyers agree to abide by all the rules applying to the WPRA Member Open Slot race and WPRA World Finals.
5. Once a buyer has paid for a slot, that buyer will have first right of refusal on re-purchase of the slot each subsequent year that there is a race. The cutoff for 2016 slot owners to exercise their right of refusal is Aug 1st.
6. **NO REFUNDS — NO EXCEPTIONS**
7. WPRA Member Open Slot race format will be one run with straight payoff.
8. WPRA Member Open Slot race competition will be run separately from the WPRA World Finals.
9. WPRA Member Open Slot race is limited. There are 2 horses per owner.
10. Slot owners do not need to be WPRA members.
11. Horses and riders must be named at check in.
12. WPRA Member Open Slot race horses will be checked in on Saturday, October 22, 2016 from 3:00 to 4:00pm at a WPRA Office. Riders will draw positions at the time of check-in.
13. WPRA Member Open Slot race competition will be run separately from the WPRA World Finals with the WPRA Member Open Slot race being held during the Saturday, October 22, 2016 evening performance.
14. Champion to receive trophy buckle and Reserve Champion to receive trophy stirrups.
15. There will be a hand rake after each run and a tractor drag after 5.
16. 5% of the purse will be payable to the WPRA.

### **GENERAL RULES: MEMBERS MUST REFER TO THE WPRA RULE BOOK**

**Dress Code:** Long-sleeved collared shirt with buttons, snaps or full length zipper on the front of the shirt, jeans without holes, western hat (helmets are acceptable for all WPRA competitions), and western boots. Per WPRA rule book.

**Next Five On Deck in the Holding Pen:** Contestant shall identify themselves to the Arena Director and be in the holding area as instructed by Arena Director prior to making their run. The Arena Director will be located next to the entryway into the holding pen.

**Failure to do so will result in a disqualification.** The announcer will call contestant's name three times within 60 seconds, if the contestant is not in the holding pen by the third call they will be disqualified. Only one horse may be in the alleyway at any time.

**Tie for Purse & Awards:** If any contestant's times are tied, the purse money will be split equally and a roll of the dice between the tied contestants will determine the tie for the awards. High roll wins.

**Payout Requirements:** Checks will be issued to the Slot owner. In order to receive your money, each owner must have a W-9 form on file in the event office. Likewise any prizes awarded in the WPRA Member Open Slot race will be awarded to the slot owner.

**Disqualifications:** In addition to anything specifically listed in these Ground Rules, refer to the WPRA rule book.

**WPRA Membership Required:** Riders of horses entered in the WPRA Member Open Slot race must be current 2016/2017 WPRA members in good standing.

**The WPRA rule book will be followed.**

**Safety:** Safety is a prime objective at this barrel race. If you have a horse that could be dangerous to yourself, other contestants, or other horses, DO NOT bring it to this barrel race. Any horse or contestant deemed to be dangerous by the management of WPRA will be disqualified and entry fees will not be refunded.
