PROGENY ENROLLMENT

Progeny of all ages shall be accepted under the grandfathering clause for \$150 per horse, for as long as the sire maintains consecutive enrollment. Horses who have not yet reached performance age (three year olds & under) may opt to pay in using the following payment system:

1st payment due on or before Dec. 31 of the weanling year	\$50
2nd payment due on or before Dec. 31 of the yearling year	\$50
3rd payment due on or before Dec. 31 of the two year old year	\$50
4th payment due on or before Dec. 31 of the three year old year	\$50

Progeny of stallions who have dropped out the P.E.S.I. program, but who are the resulting offspring from a season during which a stallion was enrolled will be accepted as follows: weanlings to three years old, either thru the above payment schedule or for a one time fee of \$200; horses four to six years old for a fee of \$400; horses six years old and older will be accepted for a fee of \$500.
