

## **2020 California Circuit DC Finals Ground Rules**

**Where:** The 2020 California Divisional Circuit Finals will take place on Saturday, January 2nd, 2021. Our finals will be hosted by K/C Arena and will be held in conjunction with the New Year's Barrel Race in the Pauline Davis Pavilion at the Red Bluff Rodeo Grounds. Time TBA.

Cut-off date for standings: September 30, 2020

**Who:** The California Divisional Finals will consist of the top 12 in the standings WHO HAVE ENTERED THE EVENT. All cardholders ( even if below the 12th position ) are encouraged to enter, as we often have to go further down into the standings to fill the 12 spots. The Permit Finals and Junior Finals will also consist of the top 12. As above, anyone below the top 12 may enter, as YOU MUST SEND IN AN ENTRY TO BE ELIGIBLE TO FILL AN OPEN POSITION.

### **Entry Information:**

Entries will open on Monday, December 7, 2020, and will close on Friday, December 11, 2020.

**\*\*New for 2020\*\*** You will be entering via email. Please send an email to [jwj ranch@gmail.com](mailto:jwj ranch@gmail.com). Your entry must include your name, horse's name, WPRC number, and category you are entering (Divisional, Permit, Junior). No phone entries. You will receive an email confirmation of your entry. Until you receive this email, your entry is not confirmed.

The Divisional Finals, Permit Finals, and Junior Finals will all be 1 run.

Entry fees: Divisional Finals: \$55+\$10 office charge  
Permit Finals: \$50+\$10 office charge  
Junior Finals: \$50+\$10 office charge

Fees may be paid via Venmo (account name TBA), PayPal (account name TBA), or by check. If sending a check, payment must be received by Wednesday, December 23, 2020. No exceptions.

Fees must be paid via Venmo or PayPal no later than Wednesday, December 30, 2020. No exceptions.

**\*\*New for 2020\*\*** No releases or refunds after December 30, 2020.

You may carry your time from the Divisional Finals race into Saturday's Open race. Please make sure to make a note on your entry form for the Open 4-D if you wish to carry your time.

Divisional Finals will have \$1000 added and will pay 4 places  
Permit Finals and Junior Finals will each have \$500 added and will pay 4 places

**Check-in:** Contestants must "check-in" by Saturday, January 2 at 10am. Checking in just means that you must confirm you are at the facility and are going to compete. You may do this via text message to (805) 550-8481.

If a contestant does not check in by January 2 at 10am, contestant will be replaced by next highest ranked barrel racer who entered.

WPRC dress code will be enforced.
