Board Meeting Minutes 9/6/23

WPR President J. Munroe calls the meeting to order.

Topic #1: Request to approve the 2023 Sioux Falls Governor's Cup Finale Ground Rules: request to approve the ground rules with edits for the 12 entries and the inclusion of the WPR patch requirement.

- The Board also discussed going back to the producer and requesting a drag in the middle.
- The Board also shared their views about paying appearance fees at these types of rodeos/finales. The requested appearance fees are \$1,000 for each barrel racer and \$500 from the WPR and \$500 from the PRCA for each breakaway roper. There are 12 contestants in each event.

Motion by California Circuit Director Sheena Robbins: I move that the Board agree to pay \$1,000 for each barrel racer and \$500 (with the PRCA putting up \$500 as well) for each breakaway roper at the 2023 Sioux Falls Governor's Cup Finale.

Topic # 2: Pilot Western Regional Event (WRE) Update: Wilderness Circuit Director/Pilot Project lead Julie Herman reviewed the potential impact of a recently announced large jackpot which is scheduled for the same time as the WRE.

- She recommended eliminating the Futurity/Derby events from the WRE.
- She recommended redistributing the added \$ from the Futurity/Derby to the remaining WPR events as follows: WPR Card – barrels- increase the add \$ from \$5000 to \$8000, WPR Permit-

barrels- increase the added \$ from \$1000 to \$2000 and the WPR A Card- breakaway- increase the added \$ from \$5000 to \$6000.

Motion by Wilderness Circuit Director Julie Herman: I move that the Board agree to eliminate the Futurity/Derby events at the WRE and redistribute the ground ruled added \$ as follows: WPR A Card – barrels- increase the add \$ from \$5000 to \$8000, WPR A Permit- barrels- increase the added \$ from \$1000 to \$2000 and the WPR A Card- breakaway- increase the added \$ from \$5000 to \$6000.

Topic #3: Discussion regarding the Interior, SD Rodeo Payout: There is a question as to whether the Interior, SD rodeo should be paid as a Day \$ payout. The WPR A office is recommending that it does falls under the Day \$ rule.

- The Board had a discussion, they reviewed the Day \$ rule, they reviewed the situation that occurred at Interior, SD and concluded that it did meet the Day \$ criteria.

Motion by WPR A Vice President Heidi Schmidt: I move that the Board accept the WPR A office recommendation concluding this is a Day \$ situation. The Day \$ should be based on 18 contestants that completed their 1st run, leave notified turnouts within that section in the payout. All other notified turnouts to be refunded.

Topic #4: Request to approve the 2023 Waco Permit Qualifier Ground Rules: WPR A President J. Munroe provided background on why Waco and the PRCA have a Permit Finals event, how the WPR A does not have a similar approach to handling permits as the PRCA and why the WPR A needs to approve the submitted Qualifier ground rules.

- KC Cox from the WPR A office shared that the ground rules are fundamentally the same as last year but include a way to handle a tie based on experience.
- J. Munroe explained that the WPR A pays the 1 day judges' fees and Waco provides the secretary, etc.

Motion by Wilderness Circuit Director Julie Herman: I move that the Board approve the 2023 Waco Permit Qualifier Ground Rules, as provided and that the WPR A will pay the judges' fees for the 1 day.

2nd by Texas Circuit Director Lois Ferguson.
